Moving Gender in International Relations

Call for papers

On **November 8, 9, 10, 11, and 12, 2021**, the II MaRIAs Seminar: Moving Gender in International Relations will be held. The presentations will be completely online, through a digital platform.

Following the proposal of the first edition of this event, the II MaRlas Seminar: Moving Gender in International Relations, seeks to further promote gender studies as a theme of International Relations studies. Incorporating, this year, the tone of the movements. We will, therefore, talk about the theoretical Gender movements in academia, the gender movements in society, and the physical movements of people, goods, and knowledge that were interrupted, hindered or adapted during the COVID-19 pandemic.

Thus, we invite all students (undergraduates and postgraduates), professors, and researchers to take ownership of this space and take part in this debate, submitting their ongoing or completed research for consideration in the second edition of the MaRlas Seminar. Our objective is to promote the dissemination of research on the subject, as well as offer the author's comments and/or criticisms that help in the development of their work. In addition, the seminar intends to integrate scientists in the area, and other students and professors who are interested in knowing more about the topic, so we will accept applications for listeners later on.

Meanwhile, the application and proposal submission process will be carried out entirely online for those interested in submitting papers. Through an application form that can be accessed through the following link: https://forms.gle/FLHLxvPi7HX43mtY7

Finally, it is recommended that, at the time of registration, the rules of the submission of works are carefully read. Since only papers that comply with the rules indicated in this notice and that are submitted within the deadline will be analyzed.

1. GENERAL RULES FOR SUBMISSION OF PROPOSALS

According to the rules below, abstracts must be submitted at registration via the link provided by September 13, 2021, at 23:59 (GTM-03:00).

There will only be one modality of presentation: panel. In this modality, works in development or complete works can be presented: articles, projects, dissertations, or theses.

1.1. Languages:

Work proposals for presentation can be submitted in Portuguese, English, or Spanish.

1.2. Number of submitted works:

Each participant may submit only **one** work as an author or co-author (maximum 3 people per work). All authors will be able to present and receive a certificate of participation.





1.3. Panel:

All panels will be composed of three or four presenters, a coordinator, and a debater. The presentations will be made through a digital platform to be indicated and will have a total duration of approximately 2 hours, with at least 30 minutes for open debate, after presentations and comments by the debater. The duration of the exhibitions of each work on panel will be up to 15 minutes per exhibitor.

1.4. Listeners:

Registration for listeners will be carried out by a panel after the disclosure of the complete program, through a specific form posted on the event's website.

2. SPECIFIC RULES FOR SUBMISSION OF PROPOSALS

2.1. Who can submit proposals?

Proposals may be submitted by undergraduates, graduates, masters, PhD students and doctors of International Relations or related fields.

2.2. Guidelines for submission of proposals:

Proposals must be submitted in the form of a Work for Panel Presentation. Upon registration, the applicant must include in the registration form, as indicated above, a short description of their work, in the specific fields that will require the following information:

- I. Research title, containing up to 200 characters with space.
- II. Thematic Area(s) to which it is linked (priority and secondary, if any).
- III. Information about other authors, if any.
- IV. Simple abstract (abstract) of up to 300 words, which must contain (under penalty of rejection of the proposal):
 - i. Clear definition of the research object, objectives, and question.
 - ii. Synthesis of the methodology or approach to the research and its sources.
 - iii. Main results obtained (complete or partial), according to the proposed objectives.

2.3. Thematic Areas

The thematic areas for the presentations of the works are divided into the following strands:

- · Security, Defence and Peace Studies
- Foreign policy
- Environment and development
- Human rights
- · Theory of International Relations
- International Political Economy
- International Institutions and Regimes
- · Sexual reproductive rights and violence against women
- Female political representation
- · Violence in conflict regions
- · Public policy

We also remind you that registration must be completed by September 13, 2021, until 23:59 (Brasilia time - GMT 03:00).

3. SELECTION CRITERIA

- I. Adequacy with the theme of the Seminar
- II. Timeliness, originality, and relevance of the theme
- III. Title relevance and abstract quality
- IV. Object delimitation and problematization
- V. Theoretical context and knowledge of the bibliography related to the research field
- IV. Clarity, relevance, and achievement of objectives.

4. SUBMISSION OF THE WORK FOR PRESENTATION

Upon acceptance of the work, notified by email, the authors will be responsible for paying the registration fee and sending the expanded abstract on a digital platform to be indicated later. Such submissions must be made by October 17, 2021, and the submission file must be named with the participant's full name ONLY. Failure to comply with the rules outlined in this notice may lead to suspension of work.

Source: Times New Roman

Line spacing: 1.5cm

Suggested structure: introduction, objectives, development, and conclusion. Bibliographic references: ABNT format with font size 12 pt. Number of pages: between

4 and 7 + cover + bibliographic references

4.3 About the text submission format:

Abstract submission in an open format: PDF

The full-text file to be submitted must reach a maximum size of 3MB including illustrations, bibliography, footnotes, tables, pagination.

Please note that certificates will be issued for event participants.
